The Little Hope Moore Water Supply Corporation (LHMWSC) Board of Directors held a public meeting on December 20, 2022 and voted to increase monthly rates on water service for all members. The Directors on the board consider these rate increases necessary to continue supporting current and upcoming projects that are critical for maintaining system infrastructure and support the escalating costs of operations. These vital improvements further ensure the continuous strategic efforts that will secure the longevity of our water system.

**LHMWSC Board of Directors have approved a \$3.99 increase to the base meter charge and an increase on each tiered rate for cost per thousand-gallon usage. These rate adjustments will be reflected in your billing beginning June 2023.**
